## Foreword

The rules are revised each year to improve the sport's level of safety and quality of play, and to clarify the meaning and intent of rules where necessary. The principles that govern all rule changes are that they must:

- be safe for the participants;
- be applicable at all levels of the sport;
- be coachable;
- be administrable by the officials;
- maintain a balance between offense and defense;
- be interesting to spectators;
- not have a prohibitive economic impact; and
- not be unduly divergent from the rules adopted by IFAF and NCAA in the USA.

These rules apply to all contests involving BAFA affiliated teams and take effect from 1st March 2014 (Exception: Competitions that began before 1st March 2014 will continue to use 2012-2013 rules until the end of their competition).

For brevity, male pronouns are used extensively in this book, but the rules are equally applicable to female and male participants.
BAFA has established a mechanism for discussing and deciding future changes to this book. Each organisation affiliated to BAFA has a voice on the Rules Committee. You may make suggestions for changes to your organisation's representative(s). Suggestions may be made at any time, but to eligible for consideration for the following year they must be received by 1st October.

## General Principle

ARTICLE 1. 8 -on- 8 football shall be played under the rules of 11 -a-side contact football with the following changes. Where a rule is in conflict with 11 -a-side rules or clearly does not apply, the 8 -on- 8 rule takes precedence.

## The Game

ARTICLE 2. a. The game shall be played between two teams of no more than 8 players each. The minimum number of players in a squad and the number of those permitted to be in uniform shall be determined by the competition committee.
b. A team may legally play with fewer than 8 players, but a foul for an illegal formation occurs if the following requirements are not met:

At the snap, at least three players wearing jerseys numbered 50 through 79 are on the offensive scrimmage line and no more than three players are in the backfield;
When the ball is free-kicked, at least three Team A players are on each side of the kicker.

## Supervision

ARTICLE 3. The game shall be played under the supervision of 4 or more officials, 3 in exceptional circumstances.

## The field

ARTICLE 4. a. The field of play (area between the goal lines) shall be a rectangular area of length 80 yards and width 40 yards marked with side lines, goal lines.
b. The end zones shall be 10 yards from goal line to end line. This may be varied to a minimum of 8 and maximum of 12 yards if necessary to fit into the playing enclosure.
c. Main lines will be marked every 5 yards across the field of play (not in the end zones).
d. Hash marks will be marked every yard in the field of play (not in the end zones) at both side lines and in the middle of the field 40 feet from each sideline. These lines should be 24 inches in length, and the hash marks at the side lines should be 4 inches away from the side line itself.
e. An additional line will be marked in the centre of the field at each 3 yard line to mark where extra point attempts will be snapped from.

## Goals

ARTICLE 5. There shall be no goal posts, all extra point attempts will be 2-point scrimmage plays and no field goals can be attempted or scored.

## The ball

ARTICLE 6. The ball shall be that mandated by the competition committee and shall be appropriate for the age group of the competing teams. Provision can be made to allow teams to use their own footballs when they are in possession, provided that they are legal.

## Kicks

ARTICLE 7. The spot for a free kick will be 10 yards from midfield unless re-located by penalty. A kick after a safety is scored on a normal scrimmage down (not a try) will be from the 20 yard line unless re-located by penalty.

## Game clock

ARTICLE 8. The game clock is any device under the direction of the appropriate official used to time the duration of the game.
a. The duration of the game may be varied by competitions.

## 25-second clock

ARTICLE 9. The 25 -second clock is any device under the direction of the appropriate official used to time the 25 seconds between the ready-for-play signal and the ball being put into play.

## Playing time

ARTICLE 10. a. The total playing time (excluding extra periods) shall be divided into 4 equal quarters. The competition committee will determine the length of quarters from $15,12,10$ or 8 minutes giving a total playing time of $60,48,40$ and 32 minutes respectively.

## Scoring

ARTICLE 11. The point value of scoring plays shall be:

| Touchdown | 6 Points |
| :--- | :--- |
| Safety (points awarded to opponents) | 2 Points |
| Successful Try Touchdown (from 3 yard line) | 2 Points |
| Successful Try Touchdown (scored by Team B) | 2 Points |

## Blocking below the waist

ARTICLE 12. Blocking below the waist will only be legal subject to meeting both of the following requirements:
The block itself would be legal under 11-on-11 rules;
The competition committee has allowed blocking below the waist for the particular age group of competing teams.
